SHORTLISTING CRITERIA

- 1. Articles of Association and valid business license.
- 2. Proof of payment of statutory obligations (e.g., Tax Clearance Certificate).
- 3. Minimum of three (3) years of relevant experience with references and recommendation letters from at least two clients.
- 4. Demonstrated capacity and ability to deliver the services.

Shortlisted service providers will receive tender documents to bid for the supply of goods and services as needed.
